ABENHEIM, Donald, is Academic Associate for Strategic Studies and an Associate Professor of National Security Affairs with the Naval Postgraduate School in Monterey, California. He holds a Ph.D. in European History and has been a visiting scholar of the Hoover Institution at Stanford. Prof. Abenheim helped to create the Center for Civil-Military Relations (CCMR) in 1993, and was its director for European programs until 2000.
